The entity structure of the Medical University Hospital Authority is that of an instrumentality or political subdivision of the State of South Carolina. As an agency of the State of South Carolina, MUHA is exempt from Federal income tax as a 501- C-3 organization. However, we are not exempt from sales, use, or local option sales tax, except where provided in the S.C. Code. All applicable sales and local option sales tax must be included on the invoice.

MUHA's payment terms follow the terms found in the South Carolina Consolidated Procurement Code Section 11-35-45. "All vouchers for payment of purchases of goods or services shall be paid within **the agreement upon terms set up during the vendor establishment. These terms are Net 30 via ePayables, Net 45 via ACH or Net 60 via Paper Check.** The payment period shall not begin until the agency certifies its satisfaction with the received goods or services and proper invoice."
