

# Pregnant & Parenting Rights Frequently Asked Questions

MUSC recognizes the unique challenges of pregnancy and parenting and is committed to supporting students and employees who have children while working or studying.



# WHAT SHOULD I DO IF I BECOME PREGNANT?

If you becomes pregnant or anticipate becoming a parent while you are a student at MUSC, we recommend contacting the Title IX Coordinator at <u>titleix@musc.edu</u> or <u>harridan@musc.edu</u>. Our office will work with you to develop a plan to accommodate the demands of having a baby while continuing to make progress toward completing your degree. Because we are a medical university, you are also encouraged to consult with your physician regarding prevention of potentially harmful exposures in the clinical or lab setting. (Employees should contact HR to request accommodations.) Please report any concerns or complaints to the Title IX Coordinator.

## WHAT KINDS OF ACCOMMODATIONS CAN I RECEIVE?

Because every student may have unique needs and degree requirements, we will work with you to create an individualized plan. In general, pregnant students are entitled to receive the same special services as students with temporary medical conditions.

# WILL MUSC EXCUSE MY ABSENCE DUE TO PREGNANCY?

Yes, MUSC will excuse your absence because of pregnancy or other related conditions for as long as is medically necessary. You may not be penalized for your absence. Upon returning to MUSC, you will be reinstated to the status you held before your absence.

# AM I ALLOWED TO MAKE UP ANY MISSED ASSIGNMENTS ?

Yes, your program must provide you with the opportunity to make up any missed work while you were out. That being said, we encourage good faith communication by all parties. If you know that you will be missing classes, assignments, tests, etc., be proactive in discussing your plans to make up missed work with your professors.

## CAN I ADD MY CHILD TO MY STUDENT HEALTH INSURANCE?

Yes, any time your family status changes, such as having a baby or adopting a child, you can add dependents to your Student Health Insurance. You should contact Academic Health Plans (AHP) directly within 31 days of your child's birth or adoption at 855-850-4302. Your child's coverage will be effective from the date of birth or adoption, and premiums will be prorated by AHP. Visit the <u>Student Health Insurance website</u> for more information.

# **ARE THERE ANY CLASSES ON PREGNANCY OR PARENTHOOD?**

MUSC Health offers several classes for new parents, including:

- basic newborn care class
- breastfeeding class
- childbirth education class (4-week series or an 8-hour Saturday class)
- infant CPR class

## WHAT OTHER RESOURCES ARE AVAILABLE TO ME?

- Those with a low risk pregnancy may join a <u>Centering Pregnancy Group</u>. The group meets 10 times for 2-hour sessions, beginning in your 12th week of pregnancy.
- <u>Postpartum Support Charleston</u> offers parents care packages, support groups, referrals, etc.
- <u>Mugs for Moms</u> offers a space to build community, engage in art therapy, and learn about mental health resources.

#### WHERE CAN I GO TO BREASTFEED OR EXPRESS MILK?

MUSC provides private spaces for expressing breast milk. Some rooms are outfitted with a hospital-grade, multi-user Medela Symphony breast pump. Some rooms require badge access. Please contact the Department of Public Safety (<u>muhcard-acess@musc.edu</u>) to request access to your selected room. The following lactation rooms are available for students and employees:

#### WHERE CAN I GET MORE INFORMATION ABOUT CHILD CARE?

**Daycare**: <u>The Division of Early Care and Education</u> provides a list of all registered daycare centers in South Carolina. The Division assigns a grade to the daycare centers from A+ to C based on five categories—program administration and structure, staff education and professional development, child well-being, family and community partnership, and intentional teaching practices. The Division of Early Care and Education also offers <u>financial assistance</u> for childcare.

**Babysitters and Nannies**: We are aware of three companies that can connect you with care providers: Care.com, Sittercity, and Urban Sitter. All three offer slightly different benefits and membership options (e.g., the option to do a background check on a prospective hire). There are also numerous Facebook groups for new parents to find nannies and babysitters, meet other parents for nanny-share arrangements, and ask for advice.

**Au Pairs:** The <u>Au Pair program</u> allows families to host individuals on a J-1 (exchange visitor) visa in exchange for live-in childcare. Au pairs are proficient in spoken English, have graduated from a secondary school or equivalent, are between 18- and 26-years old, are personally interviewed by an organizational representative, and have successfully completed a background investigation. The cost of hosting an au pair, which includes agency fees and a weekly stipend, can be competitive when compared to hiring a nanny or using daycare.
