She stated Dr. Feghali-Bostwick came to MUSC in 2013 and joined the Division of Rheumatology and Immunology as the Kitty Trask Holt Endowed Chair. She earned her Master of Science in Microbiology from the American University of Beirut in Lebanon and her PhD in Microbiology and Immunology from Tulane University. Her research work has been supported by grants from NIH; SmartState SC Centers of Economic Excellence and research agreements.

Dr. Feghali-Bostwick discussed her work in Fibrosis research. She reported that 45% of all deaths in the developed world are attributed to fibrosis, which can affect nearly any organ. There are currently no FDA-approved agents that can stop or reverse fibrosis making research in the area critical.

At the conclusion of Dr. Feghali-Bostwick's presentation, Dr. Cole presented a brief annual report. He reviewed strategy; structure; leadership and specific highlights of the past year.

Item 6. General Report of the Associate Provost for Research

Dr. Kathleen Brady, interim Associate Provost for Research, and Associate Provost for Clinical and Translational Sciences, presented the research activities report and a graph comparing extramural funding from NIH, ARRA funds and other sources. She noted that extramural awards totaled ~\$243M for FY2015, which is a 10% increase from last year. NIH funding was up by ~4%; corporate/foundation funding represented the largest increase at 30%. Much of this increase in corporate funding results from the establishment of the SCTR Research Opportunity Core.

Dr. Brady highlighted some key accomplishments over the past year. These included successes with the Patient Centered Outcomes Research Institute (PCORI). MUSC is now a part of PCORnet via a consortium with Vanderbilt and the Carolinas Collaborative (MUSC, USC, Greenville, Duke, UNC, Wake Forest). MUSC also received a PCORI grant focused on chronic back pain led by Dr. Morrisette in Health Professions, and anticipates a second award focused on postoperative anticoagulation after hip and knee replacement. NIH successes included renewal of the Clinical and Translational Science Award, and the participation in a national consortium of institutions studying adolescent brain cognitive development.

Dr. Brady also described the SC Center for Therapeutic Discovery and Development directed by Karen Lackey that has advanced drug discovery on campus. Achievements include a multi-million dollar collaboration with Bristol-Myers-Squibb, an alliance and donation of ~120,000 proprietary compounds from Aeterna Zentaris (AEZS), and the South Carolina Compound Collection (SC3) of >125,000 compounds valued at \$5-\$15M.

Mr. Jim Fisher reported on the Office of Development's most successful fundraising year in history with \$73.1 million in new gifts and pledges (66% increase from FY2014).

Highlights included: 9 gifts or pledges at \$1 million or more, top twenty gifts accounting for \$41.6 million, 4,001 new donors (first time givers) acquired and 504 new major gift prospects identified. The Office of Planned Giving received \$14 million through 42 new deferred gifts.

Mr. Fisher also reported that on-line giving had impressive results with a 17% increase amounting to \$419,000. These online communications, solicitations and invitations greatly exceeded industry benchmarks in terms of open and click-through rates. Accomplishments of the Communications Office include compiling the Annual Report of Giving and the Honor Roll of Donors, producing 266 distinct endowment reports, launching a new social media campaign, and publishing the *Legacies* newsletter. The Alumni Affairs Office sponsored 40 events with >2,700 alumni and students in attendance, coordinated the Golden Grads with 120 in attendance at Commencement, and achieved a dues participation rate of 25% in respective alumni associations across all colleges.

Gifts to the MUSC Shawn Jenkins Children's Hospital included a \$3 million cash gift and an additional \$3 million pledge from a grateful patient, \$500,000 pledge from a member of the Advisory Board, \$250,000 from Bill and Ruth Baker, and \$250,000 and \$100,000, respectively, from two members of the MUSC Foundation Board of Directors.

Other highlights since the May meeting include a \$1 million pledge to establish a statewide pediatric telehealth network and \$600,000 commitment designated for the Special Needs Dental Clinic (both from Duke Endowment). A \$1 million bequest from an alumnus was earmarked for the Physician Assistant Program. A housestaff alumnus pledged \$600,000 to the Fred Crawford Endowed Chair in Cardiothoracic Surgery. ConocoPhilips pledged \$333,000 in memory of Dr. Jim Edwards to help establish the James B. Edwards Endowed Chair in Oral and Maxillofacial Surgery.

Item 8. General Report of the CEO of the MUSC Foundation

Mr. Tom Anderson reported on the investment returns as of 6/30/15, noting that our total assets increased by \$44.5 million or 8.9% for trailing 12 months to a record level of \$541.1 million. He noted that the Foundation provided \$29.7 million for program, scholarship and capital support, both expendable and endowed, to MUSC and MUHA. Additionally, funding support (totaling \$1.66 million) to the MUSC Central Development office increased by \$150,000 or 10% over the FY2014 level. Mr. Anderson reported on investment returns on endowments as of June 30, 2015. The 1-, 3- and 5-year returns continue to exceed the benchmarks.

In terms of operating efficiency ratio, the Foundation improved its operating expense/total assets through continued expense control and asset growth from 37.5 base points in 2011 to 33.0 base points in 2015. Real estate transactions over the past year included closing on the purchase of 382 Spring Street (Crosby's Seafood) for \$772,000; closing on purchase from MUSC of respective 1.9 acre and 3.5 acre tracts in the Horizon District (now known as WestEdge) for \$98.3 million; and sale of remaining two MUSC Historic Properties at 166 and 168 Ashley Avenue for \$770,000.

Mr. Anderson reported that two new members were nominated for the Board: Ms. Beverly Wyse, Senior Boeing Executive, and Mr. Tom Parrington Former CEO of

Interstate Hotels. The Board has improved its diversity with election of two additional minority and/or women Directors. Board actions have included renegotiation of interest rate and extension of maturity on \$33.8 million in non-recourse, tax exempt real estate debt amounting to \$100,000 per year in savings. The Board also closed on the RFP selection for the 10 year taxable bank financing on acquisitions of final land assemblage in WestEdge.

In closing, Mr. Anderson presented a chart showing MUSC's NACUBO endowed asset percentile rankings over the past six years. Currently, MUSC ranks in the 27th percentile, with aspiration to reach the top quartile. A graph of the Foundation's growth in total assets since 1993 was also shown, with an impressive surge in the past few years.
