Item 6. Development Update.

Kate Azizi, Vice President for Institutional Advancement, announced that year-to-date dollars raised are currently at \$41,231,383. She also discussed the impact of philanthropic support as it relates is to the Williamsburg / Lake City Community Hospital; the new College of Pharmacy

facility and also shared the story of Catherine Rea who became a part of the MUSC Health Living Donor Program as a result of her father's need for a kidney transplant. Two new staff members have joined the Office of Development, Anahita Modaresi, Director of Corporation and Foundation Relations and Brian Panique, Senior Director of Principal Gifts.

Ms. Azizi then introduced Ms. Lisa Montgomery, EVP for Finance & Operations, are her guest speaker. Prior to Ms. Montgomery making a few remarks, Ms. Azizi announced that Ms. Montgomery is making a blended gift including planned and outright support totaling over a one million dollars which is going to support scholarships for the College of Health Professions.

Ms. Montgomery said that when she came to MUSC in 1991, she made the decision to get into the College of Health Professions MHA program. Ms. Montgomery commented that the MHA program was a wonderful experience; is a tremendous program that is nationally known, and we should all be very proud of it. We have a lot of great students that come out of that program and stay at MUSC.

In closing, Ms. Montgomery thanked the Board and leadership for their support throughout her career at MUSC and made the following statement, "if my gift can help MHA student have a career that has been half as rewarding and enriching as mine, then my gift has been a success and I hit a homerun."

Dr. Saladin opened with thanking the board on behalf of the students for allowing in-person commencement this year. The students and everyone else are excited for. Tomorrow's commencement will have 741 students graduating which are only the May graduates. Other programs have students graduating in August and December, which makes out total closer to 850. Dr. Saladin commented that with our programs continuing to expand, we will probably be at 900 soon.

Dr. Saladin then wanted to recognize Dr. Kathleen Brady, who is stepping down from her position as Vice President for Research in June after seven years. Dr. Brady is an internationally recognized psychiatrist with a research focus in the area of addictions and has been a faculty member at MUSC since 1988. She began her interim role leading research in 2014, accepting the role permanently in 2016 after a national search. Dr. Brady has been the top NIH research funded investigator on the MUSC campus for 12 consecutive years. She also was in the top 10 NIH-funded investigators in Departments of Psychiatry across the country for the past 12 years – and for four of those years, she was *the* top-funded faculty in any Department of Psychiatry in the U.S.

Dr. Brady thanked the board and administration for their support and commented there are very few places where you can work for 30 plus years and still have your career change and things continue to be exciting and am very grateful for the positions and opportunities given over the years.
