#### <u>Item 5.</u> <u>General Informational Report of the President.</u>

Dr. Cole gave a brief update to the Board on the following:

- Recent WINS: (President's Report PDF document)
- In Our DNA SC is a Precision Medicine program launched by MUSC and Helix, a national population genomics leader. Plans are to enroll 100,000 participants in genetic testing at no cost over 3 years. Participants will receive confidential results about genetic risks for certain cancers and heart disease, as well as a genetic ancestry and traits report. Testing is done using a saliva sample that will go to Helix for analysis. Results are discussed with an MUSC provider. This will develop a secure, privacy-protected genetic and research database. Approximately 1-2% of participants will have a new clinically actionable diagnosis. A 3-month pilot phase was launched to better define the process and workflow, while targeting the national benchmark for enrollment of 5.0% and we exceeded the benchmark target by enrolling 7.0%. Since the press release on March 21, enrollment is hitting 10.6%. Next steps include enrollment pathways in over 20 MUSC Health Clinics across all 4 divisions; online scheduling for community events and coming soon participants will have the option to have the collection kit shipped to their home.
- Stand Up to Cancer Grant: MUSC is leading a national lung cancer screening study. Southeastern
  Consortium for Lung Cancer Health Equity (SC3) of NCI-designated centers (VCU and UNCChapel); \$3M, 4-years, 675 patients; Marvella Ford, Ph.D., National Co-Leader, Gerard Silvestri,
  M.D., HCC Co-PI. Lung cancer is the 2nd most common cancer in the US; leading cause of cancer
  deaths. Strength of this study group: basic scientists and population and behavioral scientists

have come together to create a study that's highly translational and disparities focused. Identify and overcome barriers to lung cancer screening, access, diagnostics. Better characterization of biological heterogeneity in lung cancer risk. Ideally develop a composite risk score.

- MUSC Health National Ranking: The South Carolina Burn Center: Ranked #1 nationally for patient survival (Vizient - 2021 Q1, Q3 and Q4 quality data, adult and pediatric combined).
- State's only comprehensive burn center; First US burn center to offer minimally invasive skin graft; Leading enroller in 2 DOD/BARDA funded multicenter studies. Admissions in FY21: 275 (adult), 54 (peds); Clinic visits in FY21: 1194 (adult), 386 (peds); Surgical procedures: 437 (adult), 33 (peds); Laser procedures: 48 (March June).

# Medical University of South Carolina RESEARCH AND INSTITUTIONAL ADVANCEMENT COMMITTEE MINUTES April 7, 2022

#### Item 7. General Report of the Vice President for Institutional Advancement

Ms. Kate Azizi offered the Institutional Advancement report. As of April 5, 2022, over \$53.5M has been raised toward the FY22 fundraising goal of \$65M. Importantly, the Office of Development has brought in over \$11.2M more cash into the MUSC Foundation this year than last year thus far. Of note, this is a 37% increase over FY21 at only 8 months into the fiscal year. Ms. Azizi reviewed gifts of more than \$1M in FY22 to date. She also shared the story of Echo Buffalo, a minority COM student from Clarendon County, who has received multiple scholarships from MUSC.

#### Item 8. General Report of the Office of the Vice President for Research

Dr. Lori McMahon provided an update on discoveries in Alzheimer's Disease research which have been supported by the Carroll A. Campbell, Jr. Neuropathology Laboratory and conducted on animal models. Drs. Hongkuan Fan and Perry Halushka have been studying transcription factors that could be a target to protect from progression of disease. Additionally, Dr. Peggi Angel received an instrumentation grant for nearly \$2M from the National Institutes of Health (NIH) for a Magnetic Resonance Mass Spectrometry machine which will be critical for future studies on brain vasculature. She and Dr. Richard Drake expect to receive a grant from the NIH on high resolution mapping of biomolecules in brain cells in aging and Alzheimer's Disease which is a collaborative effort with investigators from Stanford University and the University of Kentucky. Research in Alzheimer's Disease is especially critical for our state given that South Carolina has one of the highest rates of mortality related to Alzheimer's Disease in the country. MUSC researchers are working to obtain funding from the National Institute on Aging for an Alzheimer's Disease Research Center which would be the first in our state.

Dr. Jesse Goodwin discussed efforts to improve infrastructure in support of commercialization of MUSC's intellectual property. She summarized new bylaws for the Foundation for Research Development and the Institute for Applied Neurosciences, Inc. which would realign and rebrand the two entities as the Zucker Institute for Innovation to Commercialization. This would allow for one cohesive entity with a single board with nine directors. The target date for this change is July 1, 2022.

## Education, Faculty & Student Affairs Committee April 7, 2022

#### **REGULAR AGENDA**

#### Item 10. Provost Report

Dr. Saladin reported 1,021 graduates this year with 659 scheduled to participate in the commencement ceremony at the North Charleston Coliseum on May 21 at 10:00 a.m. Aundrea Loftley, faculty member in the College of Medicine, is this year's speaker.

Dr. Terry Steyer, Interim Dean of the College of Medicine (COM), provided a brief update on the COM ranking. US News & World Report ranks MUSC COM 56 in best medical schools: research focused and 30 in publicly funded medical school, research focused. MUSC MCAT score average is 511 out of a 526-perfect score. The COM is reviewing the admission process and best practices.

Dr. Linda Weglicki, Dean, College of Nursing, provided a report on the college growth. US News & World Report 2022 ranks RN-BSN On-Line Program 3<sup>rd</sup> and ABSN program 10<sup>th</sup> in US. Overall student enrollment is trending up despite the COVID pandemic. Scholarship awards increased 30% from 2018 to 2021 with 22% of all students receiving awards. Patrick Wamsley presented the University's February 28, 2022 interim financials and reported 176 Days of Operating Cash and a favorable Operating Budget variance of \$22.6 million, or 4.05%. The results of operations for the eight months ending February 28 was \$29.4 million. Mr. Wamsley explained the impact of the different budget-to-actual-variances related to Operating Revenues such as MUSCP reimbursements, as well as Operating Expense variances related to Salaries and Fringes, and Contractual Services.
