RESEARCH AND INSTITUTIONAL ADVANCEMENT COMMITTEE MINUTES April 13, 2023

REGULAR AGENDA

Item 6. General Report of the Office of the Vice President for Research

Dr. Lori McMahon provided updates on the Office of Research.

- The MUSC Center on Healthy Aging held the Senior Expo on March 23, 2023. This was the Center's first event since the pandemic with over 500 community attendees and 134 exhibitors (more than 20 from MUSC).
- MUSC hosted the 95th annual SC Academy of Sciences meeting with nearly 500 South Carolina high school and undergraduate students attending. Dr. McMahon served as the keynote speaker, encouraging participants to continue their passion for STEM education and consider research careers and training at MUSC.
- Dr. Christopher Cowan, Chair of the Department of Neuroscience, shared exciting news about his recently funded Center of Biomedical Research Excellence (COBRE) in Neurodevelopment and Its Disorders. The \$11.3M grant supports mentorship and resources for junior faculty and funds two cutting-edge research core resources. This multidisciplinary program will elucidate how genes impact the developing brain to discover new biomarkers and treatment options for neurodevelopmental disorders such as autism spectrum disorder.
- Dr. Cowan also discussed his laboratory's research studying MEF2C which is a master regulator in brain circuit development. He has partnered with Dr. Steve Skinner of the Greenwood Genetic Center to connect with patients worldwide, mapping the genetic mutations and deletions that can be attributed to MEF2C Haploinsufficiency Syndrome. Dr. Cowan is currently working with a philanthropic donor to support these studies of rare childhood disorders.
- Cortney Gensemer, PhD, Postdoctoral Fellow in the Departments of Regenerative Medicine & Cell Biology and Neurosurgery, shared her story as a Hypermobile Ehlers-Danlos Syndrome (hEDS) patient and the work she and her mentor, Dr. Chip Norris, are doing to understand the disease. The hypermobile type of Ehlers-Danlos Syndrome (hEDS) is the most common form of EDS, making up approximately 95% of all EDS cases. It is now appreciated that 1 in 500 people globally has hEDS, which affects all organ systems in the body. Due to fragmented healthcare, many patients experience a delay in diagnosis (average of 14 years). Drs. Norris and Gensemer have discovered the first gene that causes hEDS and have developed the largest clinical registry in the world. Dr. Sunil Patel, Chair of the Department of Neurosurgery, shared that his surgery practice is filled with hEDS patients needing spine surgery and he has 30 new patients each week. Drs. Gensemer, Norris, and Patel are working to develop hEDS education for medical and other clinical practice students and to increase outreach to physicians, patients, and families. Their ultimate goal is to develop new treatments for the disease. Because of their efforts, MUSC is the global scientific and clinical leader for hEDS. Their work has been featured on news outlets such as CNN Health, FOX News, and Reader's Digest, and the team recently conducted an interview with 60 Minutes.

Item 8. Provost Report.

Dr. Lisa Saladin introduced SGA President Mackenzie Long for the SGA report. Under the advisement of the Office of Student Engagement, the SGA has 52 representatives from all six colleges and meets twice per month. SGA facilitates information and ideas, liaisons students and administration, increases quality, plans events, and maintains a budget. All meetings are now in-person. SGA programs include Back to School Bash, MUSC Night at the Aquarium, Oyster Roast, Cultural, Networking, and Recreational events. During the 2022-2023 school year, SGA members completed 1448 hours of service in our local community. To name a few, Sugar-Free Fall Fun in October, holiday comfort meals, Ronald McDonald House meals, and clean up surrounding areas of Shem Creek. Dr. Saladin introduced the new incoming SGA president, Nour Hijazi.

Dr. Saladin provided an education construction update. The work scope included renovating ~43,000sf in Colbert Education Center and Library on all floors. Renovated approximately 13,000sf of classroom space in the Basic Sciences Building and added about 40,000sf to the Basic Sciences building to relocate the College of Pharmacy. The project's goals were to provide state-of-the-art academic and student support space for the College of Pharmacy, a new flexible classroom, and instructional space for 21st-century pedagogy for all six colleges. They expanded COM student support space to comply with accreditation guidelines. The outcomes in Colbert were increased study rooms from 22 to 44. Classrooms increased from 17 to 20, furniture study seats increased from 369 to 548, and student lockers increased from 176 to 408. Dr. Saladin thanked the board for approving the project five years ago and for its ongoing support.

Item 11. MUSC Financial Report.

Patrick Wamsley, Chief Financial Officer, MUSC, presented the University's February 28, 2023, interim financials. He reported 142 Days of Operating Cash and a favorable Operating Budget variance of \$1.0 million, or .2%. Mr. Wamsley explained the impact of the different budget-to-actual variances related to Operating Revenues such as gift transfers and intra-institutional sales, as well as operating expense variances related to salaries and fringes, and contractual services.

Operating revenue was \$3M favorable with operating expenses of \$0.1M unfavorable.
