There being a quorum present, Chairman Thomas called the meeting to order. Ms. Celeste Jordan called the roll.

**Item 2. Secretary to Report Date of Next Meeting.**

**Item 3. Approval of Minutes of the Regular Meeting of the Medical University Hospital Authority of April 13, 2007.**

Board Action: It was moved that the Minutes be approved. The motion was seconded, voted on and unanimously carried.

Dr. Baker asked for an executive session, at the appropriate time, to discuss personnel and contractual matters. Dr. Thomas stated that at the conclusion of the University meeting the Board would go into executive session.

**NEW BUSINESS:**

**Item 4. General Informational Report of the President.**

Dr. Greenberg introduced Dr. Tom Keane, the Chair of the Urology Department who specializes in treating prostate and bladder cancer. He has recruited a fantastic team of colleagues and has built a strong clinical and research program.

Dr. Keane said the hospital is about to make a significant investment in the da Vinci robot and many consider it is the wave of the future. It is a major marketing tool and will also help the University attract the best residents in the country by having leading technology. Dr. Keane said he resisted getting the robot for about two years but he said the robot has stood the test of time, and he was pleased the University was investing in the robot.

Dr. Greenberg commented that in addition to Dr. Keane's great skills he is very customer service oriented and will always see another patient even though his schedule is over loaded. Dr. Johnson echoed that observation and said Dr. Keane's commitment to service was reflected in his colleagues as well.

**Item 6. MUSC Medical Center Status Report.**

Statement: Mr. Stuart Smith distributed a statistical report through April. Admissions increased 7.6%; emergency room visits increased 6.3% and outpatient visits 8%. The Authority faces a real budget challenge with the opening of the new hospital. Debt service will take away the positive margins. The hospital must grow and grow rapidly and projections based on the surgeons hired – 25% increase in operating rooms - should give relief to the surgeons. If the pent-up demand is out there, which has been predicted, the Authority will quickly accelerate growth which will generate the revenues and offset the debt service and prepare the University for Phase II.

He stated the Authority is working on the budget, what Phase II may look like and the move to the new hospital. The Authority is working hard to upgrade information technology and he is pleased with the progress in that area. Four service lines will be rolled out July 1 and the MUSC Excellence journey continues.

**Item 7. MUSC Medical Center Financial and Statistical Report.**

Statement: Ms. Lisa Montgomery reported that the Authority is still behind budget by about \$3 million due to acceleration of IT expenditures and a transfer of the design work of the new garage to the University. She remains hopeful that the Authority will be on budget by year end.

Ms. Montgomery said this will probably be the last time she will be able to report 5% margins for some time. In 2000, when the Authority began, it had a \$23 million loss that year and had no cash in the bank. Today, the Authority has a 5% margin and \$85 million (45 days) cash on hand which is the highest it has been since the Authority began. If you look at the benchmark data for the Authority's peers, 8 of the 9 indicators show the Authority ranks better than 50% of its peers. In 4 of the indicators the Authority ranks better than 75% of its peers. She remarked that the position the Authority is presently in is a testimony to the hard work of many people since 2000.

**Item 9. Report on University Medical Associates.**

Statement: Dr. Feussner gave an update on Mohs Surgery in the Department of Dermatology and a proposed two-step approach to protect market and improve patient access and satisfaction. He proposed to move a Mohs surgeon in July 2007 to the north area and recruit a third Mohs surgeon to respond to increased demand for this specialty. He asked for approval for the following expenditures in connection with a new north area location:

- Start Up Expenses – Totaling \$487,900
  - Office furniture and Equipment - \$33,900
  - Medical Equipment - \$129,000
  - Upfit (Includes Ventilation System) – \$312,500
  - Architecture Fees - \$12,500

Recommendation of Administration: That the expenditures be approved.

Recommendation of Committee: Committee did not meet.

Board Action: A motion was made to approve the start up expenditures totaling \$487,900 for a new North Area Mohs surgery location. The motion was seconded, voted on and unanimously carried.

**Item 10. Legislative Update.**

Statement: Mr. Faulkner reported that an appropriations bill is in conference committee and the University is in good shape, at present. The Senate Finance Committee passed the cigarette tax to the floor which should be debated next week which could put \$95 million toward healthcare. There is a bill being debated about concealed weapons on campus as a result of the Virginia Tech incident. The bill is of concern to the University and the progress of the bill is being closely watched.
