GIFTS AND GRANTS TO THE MEDICAL UNIVERSITY OF SOUTH CAROLINA AND THE MEDICAL UNIVERSITY OF SOUTH CAROLINA HOSPITAL AUTHORITY TO PROMOTE EDUCATION, RESEARCH AND OTHER PROGRAMS. FOR FY20 SIGNIFICANT SUPPORT WAS PROVIDED TO RESPOND TO THE COVID-19 PANDEMIC. AMONG THIS SUPPORT, RESOURCES WERE USED TO INTEGRATE RESEARCH AND CLINICAL EFFORTS TO INCREASE DIAGNOSTIC AND ANTIBODY TESTING, TREATMENT, AND CLINICAL TRIALS. CRITICAL SUPPLIES AND STAFFING NEEDS WERE ALSO MET THROUGH THIS SUPPORT. OUTREACH TO THE COMMUNITY AND THE GROWTH IN SERVING THE STATE THROUGH THE CREATION OF A REGIONAL HEALTH NETWORK WAS A TRANSFORMATIVE ACCOMPLISHMENT OF THE MUSC HEALTH SYSTEM FOR SERVING THE NEEDS OF THE STATE'S CITIZENS.

STUDENT SCHOLARSHIPS - THE MUSC ENTERPRISE IS FOCUSED ON THE AFFORDABILITY OF MEDICAL EDUCATION THROUGH SCHOLARSHIP OPPORTUNITIES FOR STUDENTS. TO THIS EFFORT, THE FOUNDATION HAS PARTNERED WITH MUSC TO INCREASE ITS SUPPORT OF SCHOLARSHIPS NOW AND IN THE FUTURE. SIGNIFICANT SCHOLARSHIP SUPPORT WAS AWARDED ACROSS ALL 6 COLLEGES THAT ENABLED STUDENTS TO BEGIN OR CONTINUE THEIR GOALS IN MEDICAL EDUCATION. THE RESOURCES PROVIDED BY THE FOUNDATION WERE COMBINED WITH OTHER RESOURCES OF MUSC TO CREATE APPROXIMATELY \$6.5 MILLION AWARDED DOLLARS TO THESE STUDENTS.
